WHEREAS, Section 20 (a) of R. A. 7160 or the Local Government Code of 1991 grants a municipality the power to authorize the reclassification of agricultural lands into a residential, commercial or industrial purposes and was more specifically stated as follows:

"A city or municipality may, through an ordinance passed by the Sanggunian after conducting public hearings for the purpose, authorize the reclassification of agricultural lands and provide for the manner of their utilization or disposition in the following cases: (1) when the land ceases to be economically feasible and sound for agricultural purposes as determined by the Department of Agriculture or (2) where the land shall have substantially greater economic value for residential, commercial, or industrial purposes, as determined by the Sanggunian concerned: Provided, That such reclassification shall be limited to the following percentage of the total agricultural land area at the time of the passage of the ordinance";

WHEREAS, Ordinance No. 2022-1288 was enacted by the Sangguniang Bayan of the Municipality of San Mariano, Isabela, which reclassified a lot containing 16.6771 hectares, more or less, from agricultural to agro-industrial purposes, located in Barangay Binatug, San Mariano, Isabela;

WHEREAS, the Sangguniang Panlalawigan Committee on Housing, Subdivision and Land Use Classification conducted a thorough review of Ordinance No.2022-1288 and found the same to be in consonance to the mandate of the Sangguniang Bayan;

WHEREAS, the Committee on Housing, Subdivision and Land Use Classification recommended the approval of Ordinance No. 2022-1288 of the Municipality of San Mariano, Isabela, to which this August Body approved;

NOW THEREFORE, upon motion of **HON. MARY GRACE D. ARREOLA**, duly approved and seconded in a session duly assembled, it was –
