WHEREAS, Section 20 (a) of R. A. 7160 or the Local Government Code of 1991 grants a municipality the power to authorize the reclassification of agricultural lands into a residential, commercial or industrial purposes and was more specifically stated as follows:

"A city or municipality may, through an ordinance passed by the Sanggunian after conducting public hearings for the purpose, authorize the reclassification of agricultural lands and provide for the manner of their utilization or disposition in

the following cases: (1) when the land ceases to be economically feasible and sound for agricultural purposes as determined by the Department of Agriculture or (2) where the land shall have substantially greater economic value for residential, commercial, or industrial purposes, as determined by the Sanggunian concerned: Provided, That such reclassification shall be limited to the following percentage of the total agricultural land area at the time of the passage of the ordinance";

WHEREAS, Ordinance No. 22-021 was enacted by the Sangguniang Bayan of the Municipality of Roxas, Isabela, which reclassified a lot containing 658 square meters, more or less, from agricultural to residential purposes, covered under TCT NO. T-262868 with Lot No. 477B-2-B-1-B-1, located in Barangay San Rizal, Roxas, Isabela;

WHEREAS, the Sangguniang Panlalawigan Committee on Housing, Subdivision and Land Use Classification conducted a thorough review of Ordinance No.22-021 and found the same to be in consonance to the mandate of the Sangguniang Bayan;

WHEREAS, the Committee on Housing, Subdivision and Land Use Classification recommended the approval of Ordinance No. 22-021 of the Municipality of Roxas, Isabela, to which this August Body approved;

NOW THEREFORE, upon motion of HON. MARY GRACE D. ARREOLA, duly approved and seconded in a session duly assembled, it was —

RESOLVED, AS IT HEREBY RESOLVES, TO PASS A RESOLUTION UPHOLDING THE VALIDITY OF ORDINANCE NO. 22-021 OF THE MUNICIPALITY OF ROXAS, ISABELA ENTITLED, "AN ORDINANCE RECLASSIFIYING THE SIX HUNDRED FIFTY-EIGHT (658) SQUARE METER PORTION OF AGRICULTURAL LAND UNDER THE NAME OF ORLANDO ACUPIDO AND MARCELINA ACUPIDO, COVERED UNDER TCT NO.
