WHEREAS, the Department of Education (DepEd), being the primary government instrumentality mandated to formulate, implement, and coordinate policies, plans, programs, and projects in the areas of formal and non-formal education, is tasked to ensure that graduates of basic education are ready for employment, entrepreneurship, and higher learning;

WHEREAS, the Department of Education implemented Work Immersion which aims to better equip the senior high school students for further education, employment, or entrepreneurship;

WHEREAS, to realize the objective of the Department of Education, the Isabela School of Arts and Trades (ISAT) intends to enter into a Memorandum of Agreement for Work Immersion Partnership with the Provincial Government of Isabela(PGI);

WHEREAS, the PGI is one with the DepEd in advocating competence and dedication in serving its constituents, as this promotes inclusive economic growth, and creates a dynamic and socially responsible community;

WHEREAS, in support to the pursuit of the DepEd and ISAT, the PGI is desirous to enter into a Memorandum of Agreement with the ISAT for the implementation of the Work Immersion Program to inculcate life and career skills to the Senior High School students, and to develop in them the essential values, appreciation, and respect for work:

WHEREAS, under Section 465, (b) (1) (vi) of R. A. No. 7160, the Provincial Governor is empowered to represent the Province in all its transactions and sign on its behalf all contracts and such other documents upon the issuance of an authority by the Sangguniang Panlalawigan;

WHEREAS, this Body deems it beneficial and advantageous for the Province to grant the Provincial Governor the necessary authority to sign the aforesaid Memorandum of Agreement on behalf of the Provincial Government of Isabela;
