WHEREAS, as a manifestation of its support to such offices, the Provincial Government of Isabela closely works and coordinates with them in formulating, planning, and implementing programs and initiatives aimed at improving the lives of the Isabeleños.

WHEREAS, corollary to this, the Provincial Government of Isabela has allowed to construct and operate in its property the Department of Public Works and Highways –  $1^{st}$  District Engineering Office (DPWH –  $1^{st}$ );

WHEREAS, to formalize such tolerance to utilize its land and to further deepen the partnership of both institutions, the Provincial Government of Isabela is willing to execute an instrument that will grant DPWH -1<sup>st</sup> with usufructuary rights for a period of fifty (50) years, extendible upon mutual agreement of both parties, over the land to which the latter's office is situated. Such an instrument was submitted to this August Body for its review and approval.

WHEREAS, after careful perusal, this August Body deems the proposed instrument to be executed by the two institutions to be just, lawful, and in line with the policies of the Provincial Government of Isabela in maintaining and strengthening its mutually productive relations with the provincial offices of national government agencies;

WHEREAS, Section 465(b)(1)(vi) of the Local Government Code empowers the Provincial Governor to represent the Province in all its transaction and sign on its behalf all contracts and such other documents upon the issuance of authority by the Sangguniang Panlalawigan;

WHEREAS, this August Body deems it beneficial and advantageous for the Province to grant the Provincial Governor the necessary authority to sign the mentioned agreement on behalf of the Provincial Government of Isabela;

**WHEREAS,** upon motion of the Honorable Victor G. Dy, duly approved and seconded in a session duly assembled, it was –
