A RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR, THE HONORABLE RODOLFO T. ALBANO III, TO SIGN ON BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA A MEMORANDUM OF AGREEMENT THAT WILL ALLOW DR. KATHLEEN KAY P. JUSTO, M.D., MEDICAL SPECIALIST II IN THE MILAGROS ALBANO DISTRICT HOSPITAL (MADH), TO UNDERGO A FELLOWSHIP TRAINING WITH THE EAST AVENUE MEDICAL CENTER

WHEREAS, in line with such a policy, the PGI commits to exploring all possible lawful means to improve its medical and healthcare services, including the establishment of partnership agreements with private institutions that will provide education and training to PGI personnel;

WHEREAS, presented before this August Body is a letter from the Provincial Governor, the Honorable Rodolfo T. Albano III, expressing his request to be granted the necessary authority to sign a Memorandum of Agreement with the East Avenue Medical Center on behalf of the PGI;

WHEREAS, under such an agreement, the East Avenue Medical Center will accept an employee of the PGI in the person of Dr. Kathleen Kay P. Justo, M.D., Medical Specialist II in the Milagros Albano District Hospital (MADH), who will undergo a Fellowship Training in the field of Computed Tomography and Magnetic Resonance Imaging (CT-MRI) for two weeks of duty per month over a five-month period. In turn, Dr. Justo will apply the expertise and education acquired through the aforementioned training in providing services to the PGI;

WHEREAS, after careful review of such an agreement, this August Body determined that the same is just and lawful, will benefit the Isabeleños, and advances the PGI policy on providing quality, affordable and accessible medical and healthcare services to the people;

WHEREAS, Section 465(b)(1)(i) of R.A. No. 7160 empowers the Provincial Governor to represent the Province in all its transactions and sign on its behalf all contracts and such other documents upon the issuance of an authority by the Sangguniang Panlalawigan;

WHEREAS, upon motion of the Honorable Emmanuel Joselito B. Añes, duly approved and seconded in a session duly assembled, it was –
