WHEREAS, Ordinance No. 05-2022, an Ordinance appropriating the amount of TWO MILLION FIFTY THOUSAND THREE HUNDRED THIRTY TWO PESOS & 14/100 (P2,050,332.14) as savings from vacant positions of Personal Services for Calendar Year 2022 to fund the upgraded salaries of Nurse positions and newly created Nurse III position under the Municipal Health Office of the Municipality of Ramon, Isabela, was submitted to this Sanggunian for review pursuant to the provisions of Section 327 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

A RESOLUTION DECLARING ORDINANCE NO. 05-2022 (SUPPLEMENTAL BUDGET NO. 02-2022) IN THE AMOUNT OF TWO MILLION FIFTY THOUSAND THREE HUNDRED THIRTY TWO PESOS & 14/100 (P2,050,332.14) OF THE MUNICIPALITY OF RAMON, ISABELA OPERATIVE IN ITS ENTIRETY

NOW THEREFORE, on motion of **SP Member DELFINITO EMMANUEL L. ALBANO** duly seconded:

RESOLVED, to declare Appropriation Ordinance No. 05-2022 (Supplemental Budget No. 2 FY 2022 of the Municipality of Ramon, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of Republic Act No. 7160 and subject further to the following condition:

- The creation of positions shall be consistent with the rules and regulations as prescribed under CSC Memorandum Circular No. 12, series of 2022. Further, creation of non-mandatory positions and offices in LGUs may be allowed subject to the following conditions:
 - a. That they are priority needs as identified by the LCE, the Sanggunian and/or LDCs concerned consistent with Section 17 of RA No. 7160;
 - b. All mandatory positions stipulated under RA No. 7160 and other pertinent laws have been created and provided;
 - c. The SSL has been fully implemented;
 - d. The general limitations on PS expenditures are not exceeded;
- 2. The modification of Nurse positions shall be in accordance with DBM Budget Circular No. 2021-2, dated August 25, 2021;
- 3. The creation of the position of Nurse IV SG-19/1 under Municipal Ordinance No. 15-22 is not in accordance with Section 4(d) of Local Budget Circular No. 53, which states that the highest level of Position below Assistant Department Head shall be allocated to SG 18 for 1st to 3rd Class Municipalities. Since the subject position does not conform to the herein prescribed allowable SG allocation, the creation of the position of Nurse IV is therefore disallowed;

RESOLVED FURTHER, to inform the Municipality of Ramon, Isabela that this review action does not authorize any item of appropriation that is/are specifically prohibited by or inconsistent with the provisions of law, and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations.

RESOLVED FINALLY, to furnish a copy of this Resolution to the **Honorable JESUS D. LADDARAN**, Municipal Mayor, and to the Sangguniang Bayan of the Municipality of Ramon, Isabela through **Honorable DENNIS JON DELA CRUZ**, Municipal Vice-Mayor.
