WHEREAS, the Provincial Government of Isabela recognizes the advantages of the Government Internship Program of DOLE as it aims to create more employment opportunities in the Province and strives to develop the marketability and competitiveness of the Isabeleño youth;

WHEREAS, submitted to this August Body is the proposed Memorandum of Agreement between the Provincial Government of Isabela and DOLE RO2 for the deployment of interns under the Government Internship Program to the departments and offices of the Provincial Government of Isabela;

WHEREAS, after careful review, this August Body finds the submitted Memorandum of Agreement to be just, lawful, and promotive of the welfare of Isabeleños;

WHEREAS, Section 465(b)(1)(vi) of R. A. No. 7160 empowers the Provincial Governor to represent the Province in all its transactions and sign contracts and such other documents relative to the execution of his functions, upon the authority vested upon him by the Sangguniang Panlalawigan;

WHEREAS, this August Body deems it beneficial and advantageous for the Province to grant the Provincial Governor the necessary authority to sign the Memorandum of Agreement on behalf of the PGI;

WHEREFORE, upon motion of the Honorable Evyn Jay C. Diaz, duly approved and seconded by all members in a session duly assembled, it was –
