WHEREAS, in furtherance of its mandate and commitment to protect and promote the health of its people, the Provincial Government of Isabela implements a wide array of health programs that address the varying health needs of its people. One such program is its mass vaccination of dogs program which aims to achieve zero-rabies case in the Province of Isabela;

WHEREAS, the Provincial Government of Isabela and the Isabela State University share a productive partnership founded on their mutual goal to uplift the living conditions of people in the Province of Isabela;

WHEREAS, the Provincial Government of Isabela and the Isabela State University have agreed to work together to achieve zero-rabies case in the Province of Isabela;

WHEREAS, to advance their mutual endeavor, the Isabela State University has manifested its commitment to provide manpower to the Provincial Government of Isabela for its mass vaccination of dogs program;

WHEREAS, submitted to this August Body is the proposed Memorandum of Agreement between the Provincial Government of Isabela and the Isabela State University in which the latter agrees to deploy its qualified Doctor of Veterinary Medicine students to assist the former in the implementation of its mass vaccination of dogs program, among other obligations of the two institutions;

WHEREAS, after careful review of the said proposed agreement, this August Body deems it to be just, appropriate, and advances the health plans and goals of the Provincial Government of Isabela;

WHEREAS, Section 465(b)(1)(vi) of the Local Government Code empowers the Provincial Governor to represent the Province in all its transaction and sign on its behalf all contracts and such other documents upon the issuance of authority by the Sangguniang Panlalawigan;

WHEREAS, this August Body deems it beneficial and advantageous for the Province to grant the Provincial Governor the necessary authority to sign the mentioned agreement on behalf of the Provincial Government of Isabela;

WHEREAS, upon motion of the Honorable Emmanuel Joselito B. Añes, duly approved and seconded in a session duly assembled, it was –
