ALBANO III, TO SIGN ON BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA A MEMORANDUM OF AGREEMENT WITH THE PHILIPPINE NATIONAL POLICE – ISABELA POLICE PROVINCIAL OFFICE FOR THE INSTITUTIONALIZATION OF A PARTNERSHIP MECHANISM FOR THE PROMOTION OF THE RIGHTS AND WELFARE OF WOMEN AND CHILDREN IN THE PROVINCE OF ISABELA AND ADDRESSING VIOLENCE AND OTHER CRIMES COMMITTED AGAINST SUCH INDIVIDUALS

WHEREAS, the Provincial Government of Isabela fully adheres to such State policy and observes an unyielding commitment to protect and advance the safety and welfare of women and children;

WHEREAS, the Philippine National Police – Isabela Police Provincial Office (IPPO) is a subdivision of the Philippine National Police, created pursuant to Republic Act No. 6975 as amended by Republic Act No. 8551, that is tasked to perform the functions and implement the programs of the latter in the Province of Isabela;

WHEREAS, the Provincial Government of Isabela and the IPPO aspire to further enhance existing local mechanisms for the promotion of the rights and welfare of women and children in the Province of Isabela and in handling and resolving crimes committed against them;

WHEREAS, the aspiration of both institutions has been manifested through a proposed Memorandum of Agreement, which they seek to enter into, that seeks to enhance their coordination and communication lines for the implementation of programs that seek to promote the rights and welfare of women and children in the Province of Isabela and in handling and resolving cases that involve crimes committed against such individuals;

WHEREAS, submitted to this August Body is the mentioned proposed Memorandum of Agreement to be entered into by and between the Provincial Government of Isabela and the IPPO;

WHEREAS, after careful review of such an agreement, this August Body determined the same to be just, lawful, and promotive of the welfare of Isabeleños;

WHEREAS, Section 465(b)(1)(vi) of R. A. No. 7160 empowers the Provincial Governor to represent the Province in all its transactions and sign contracts and such other documents relative to the execution of his functions, upon the authority vested upon him by the Sangguniang Panlalawigan;

WHEREAS, this August Body deems it beneficial and advantageous for the Province to grant the Provincial Governor the necessary authority to sign the Memorandum of Agreement on behalf of the Provincial Government of Isabela;

WHEREFORE, upon motion of the Honorable Lourdes S. Panganiban, duly approved and seconded by all members in a session duly assembled, it was –
