ALBANO III, TO SIGN ON BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA A MEMORANDUM OF AGREEMENT AUTHORIZING THE MALLIG DAIRY MULTIPURPOSE COOPERATIVE TO MANAGE AND OPERATE THE ISABELA DAIRY ENTERPRISE IN MALLIG, ISABELA

WHEREAS, the Provincial Government of Isabela upholds a policy in which it accords preferential consideration to the continued development of the agriculture sector in the formulation of its policies and implementation of its programs;

A RESOLUTION GRANTING AUTHORITY TO THE PROVINCIAL GOVERNOR, THE HONORABLE RODOLFO T. ALBANO III, TO SIGN ON BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA A MEMORANDUM OF AGREEMENT AUTHORIZING THE MALLIG DAIRY MULTIPURPOSE COOPERATIVE TO MANAGE AND OPERATE THE ISABELA DAIRY ENTERPRISE IN MALLIG, ISABELA

WHEREAS, the Provincial Government of Isabela envisions to increase farm productivity and incomes in strategic areas of the province;

WHEREAS, the Provincial Government of Isabela endeavors to improve the access of farmers and other industry players to a strategic network of infrastructure, market information, and support services. In line with this pursuit, it seeks to engage the private sector to help improve the production performance of Isabela Dairy Enterprise;

WHEREAS, the Mallig Dairy Multipurpose Cooperative (or MADAMCO) is a duly organized cooperative duly registered with the Cooperative Development Authority;

WHEREAS, the Municipal Government Unit of Mallig, Isabela (LGU Mallig) endorsed MADAMCO to the Provincial Government of Isabela for the handling of the management and operations of the Isabela Dairy Enterprise;

WHEREAS, the Provincial Government of Isabela considered the endorsement of LGU Mallig and conducted an assessment of the capacity of MADAMCO to handle the management and operations of the Isabela Dairy Enterprise;

WHEREAS, the Provincial Cooperative, Livelihood, and Enterprise Development Office determined that MADAMCO is organizationally and financially capable to manage and operate the Isabela Dairy Enterprise;

WHEREAS, through such finding, the Provincial Government of Isabela aspires to transfer to MADAMCO the management and operations of the Isabela Dairy Enterprise. This was manifested through the submission of a document from the Office of the Provincial Governor to this August Body, for its review and approval, requesting that the Provincial Governor, the Honorable Rodolfo T. Albano III be granted with authority to sign on behalf of the Provincial Government of Isabela a Memorandum of Agreement that will transfer to MADAMCO the management and operations of the Isabela Dairy Enterprise;

WHEREAS, after careful review of such an agreement, this August Body determined the same to be just and lawful, and will maximize and improve the utility of the Isabela Dairy Enterprise to the benefit of the Isabeleños;

WHEREAS, Section 465(b)(1)(vi) of R. A. No. 7160 empowers the Provincial Governor to represent the Province in all its transactions and sign contracts and such other documents relative to the execution of his functions, upon the authority vested upon him by the Sangguniang Panlalawigan;

WHEREAS, this August Body deems it beneficial and advantageous for the Province to grant the Provincial Governor the necessary authority to sign the Memorandum of Agreement on behalf of the Provincial Government of Isabela;

WHEREFORE, upon motion of the Honorable Adrian Philip S. Baysac, duly approved and seconded by all members in a session duly assembled, it was –
