

A RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR, HONORABLE RODOLFO T. ALBANO III, TO SIGN ON BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA, A MEMORANDUM OF AGREEMENT WITH THE ISABELA STATE UNIVERSITY – ROXAS FOR THE IMPLEMENTATION OF THE WORK IMMERSION PARTNERSHIP PROGRAM

WHEREAS, the Department of Education (DepEd) is the primary government instrumentality mandated to formulate, implement, and coordinate policies, plans, programs, and projects in the areas of formal and non-formal education;

WHEREAS, the Department of Education has formulated the Work Immersion Partnership Program in which education institutions offering the Senior High School (SHS) curriculum are enjoined to deploy for a brief period their SHS students to government and private offices that are deemed capable to provide proper professional training to enhance their competitiveness and employability;

**WHEREAS,** the Isabela State University – Roxas Campus (ISU Roxas) is among those educational institutions that are duly authorized by the DepEd to offer the Senior High School curriculum;

WHEREAS, to realize the educational objectives of the DepEd and the ISU, the ISU aspires to partner with the Provincial Government of Isabela in implementing the Work Immersion Partnership Program;

WHEREAS, such intention to partner is manifested through the mutual desire of the Provincial Government of Isabela and the ISU to enter into a Memorandum of Agreement (MOA) for the implementation of the Work Immersion Partnership Program. Such MOA has been submitted to this August Body for its review and approval;

WHEREAS, it is the policy of the Provincial Government of Isabela to ensure that its people have access to affordable and quality education. In line with this policy, the Provincial Government of Isabela actively advocates for the conduct of activities that will inculcate life and career skills to the Senior High School students, and to develop in them the essential values, appreciation, and respect for work;

WHEREAS, under Section 465(b)(1)(vi) of R. A. No. 7160, the Provincial Governor is empowered to represent the Province in all its transactions and sign on its behalf all contracts and such other documents upon the issuance of an authority by the Sangguniang Panlalawigan;

WHEREAS, this Body deems it beneficial and advantageous for the Province to grant the Provincial Governor the necessary authority to sign the aforesaid Memorandum of Agreement on behalf of the Provincial Government of Isabela;

**WHEREFORE**, upon motion of the Honorable Mary Grace D. Arreola, duly approved and seconded in a session duly assembled, it was -
