A RESOLUTION DECLARING MUNICIPAL ORDINANCE NO. 23-002 OF THE SANGGUNIANG BAYAN OF ROXAS, ISABELA AS INTRA VIRES

WHEREAS, pursuant to Article 468(a)(i) of the Local Government Code, the Sangguniang Panlalawigan has the authority to "review all ordinances approved by the sangguniang of component cities and municipalities" and to "determine whether these are within the scope of the prescribed powers of the sanggunian and of the mayor"

WHEREAS, presented before this Honorable Body is Municipal Ordinance No. 23-002, enacted by the Sangguniang Bayan of Roxas, Isabela titled "AN ORDINANCE RECLASSIFYING A TOTAL OF TWO HUNDRED SEVENTY-TWO (272) SQUARE METERS MORE OR LESS OF RESIDENTIAL LAND UNDER THE NAME OF ANTONIO CONCEPCION, JR. COVERED UNDER TCT NO. T-229446, SITUATED IN BARANGAY SAN ANTONIO, MUNICIPALITY OF ROXAS, ISABELA TO COMMERCIAL USE.";

WHEREAS, the Municipal Local Government Unit of Roxas, Isabela, pursuant to a Zoning Ordinance duly enacted by their Sangguniang Bayan, recognizes "Commercial zone" as a valid land use classification within their jurisdiction;

WHEREAS, this Honorable Body recognizes that local government units are more abreast with regard to the needs of their citizens and the conditions within their jurisdiction and thus have the necessary competence in formulating the appropriate strategies and implementing the essential measures for the advancement of their people and territory;

WHEREAS, after careful review, subject to pertinent regulations and issuances of the Housing and Land Use Regulatory Board and other relevant laws and rules, this Honorable Body finds that the reclassification of the aforementioned land from residential to commercial zone made pursuant to Ordinance No. 23-002 of the Sangguniang Bayan of Roxas, Isabela to be a valid exercise of their legislative power and is within the authority of the Municipal Local Government Unit of Roxas, Isabela as prescribed by law;

**WHEREFORE**, upon motion of the Honorable Mary Grace D. Arreola, duly approved and seconded in a session duly assembled, it was —

RESOLVED, AS IT HEREBY RESOLVES, TO PASS A RESOLUTION DECLARING MUNICIPAL ORDINANCE NO. 23-002 OF THE SANGGUNIANG BAYAN OF ROXAS, ISABELA AS INTRA VIRES
