WHEREAS, the Northeastern Luzon Pacific Coastal Services, Inc. (NLPCSI) was established on January 19, 2004, as part of the "Strong Nautical Highway" program initiated by then-President Gloria Macapagal-Arroyo to enhance maritime connectivity and promote economic development;

WHEREAS, the Province of Isabela, as a key stakeholder, holds stock in and is a member of the Board of Directors of NLPCSI, a Non-Chartered Government-Owned and Controlled Corporation (GOCC), with vested interests in the corporation's performance and ongoing activities, especially in matters related to its corporate affairs;

WHEREAS, the NLPCSI is scheduled to hold a Board Meeting on January 23, 2025, via Zoom teleconference, to deliberate significant matters including the proposal to dissolve the corporation, the amendment of its corporate term, and other business concerns;

WHEREAS, in addition, both Atty. Torio and Atty. Cureg-Binag have requested to be formally appointed as proxies for the Province of Isabela, granting them the authority to exercise its voting rights in anticipation of the forthcoming stockholders' meeting;

WHEREAS, Atty. John Ryan P. Torio and Atty. Elizabeth P. Cureg-Binag, in their capacities as Provincial Legal Officer and Provincial Information Officer, have consistently demonstrated effective leadership in their respective roles and have earned a reputation for professionalism, legal expertise, and effective communication, ensuring that the Province of Isabela's interests are well represented in legal and governance matters;

WHEREAS, the Sangguniang Panlalawigan recognizes the importance of proper representation of the Province of Isabela in the corporate proceedings of NLPCSI, particularly in matters that directly affect its interests;

WHEREAS, under Section 465, (b) (1) (vi) of R.A. No. 7160, the Governor is empowered to represent the Province in all its transactions and sign on its behalf all contracts and such other documents upon the issuance of an authority by the Sangguniang Panlalawigan;

WHEREAS, this Body deems it necessary to grant authority to Atty. Torio and Atty. Cureg-Binag to effectively represent the Province of Isabela in the upcoming NLPCSI Board and Stockholders' meetings, ensuring that the province's interests are safeguarded and that decisions align with its goals and priorities;

WHEREFORE, upon careful review of the foregoing, and upon motion of the Honorable Clifford R. Raspado, duly approved and seconded in a session duly assembled, it was –
