ALBANO III, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF MIGRANT WORKERS, DEPARTMENT OF LABOR AND EMPLOYMENT, AND TECHNICAL EDUCATION AND SKILLS DEVELOPMENT AUTHORITY FOR THE COOPERATIVE UNDERTAKING TO PROMOTE THE RIGHTS AND WELFARE OF THE PUBLIC, MIGRANT WORKERS, AND MEMBERS OF THEIR FAMILIES

WHEREAS, the Department of Migrant Workers (DMW), the Department of Labor and Employment (DOLE), and the Technical Education and Skills Development Authority (TESDA) share the responsibility of ensuring the protection, welfare, and development of migrant workers, facilitating their legal rights, skills development, and the social benefits for their families;

WHEREAS, the collaboration between the Provincial Government of Isabela, DMW, DOLE, and TESDA is intended to enhance the efforts of all entities involved in the provision of services and support for migrant workers and their families, focusing on promoting education, financial literacy, skills training, and legal protection;

WHEREAS, entering into a Memorandum of Agreement with DMW, DOLE, and TESDA will formalize the partnership between these key agencies and the PGI, ensuring a streamlined and efficient system for delivering services to migrant workers, empowering them through education, livelihood support, and legal protection, as well as enhancing the coordination between national and local government efforts to better address the needs of the families of migrant workers;

WHEREAS, submitted for the review and approval of this Honorable Body is the proposed Memorandum of Agreement between the PGI, DMW, DOLE, and TESDA, providing their respective duties and functions to ensure the effective implementation of joint initiatives aimed at promoting the welfare and rights of migrant workers and their families, particularly through educational opportunities, skill development programs, legal protections, and employment support;

WHEREAS, under Section 465, (b) (1) (vi) of R. A. No. 7160, the Governor is empowered to represent the Province in all its transactions and sign on its behalf all contracts and such other documents upon the issuance of an authority by the Sangguniang Panlalawigan;

WHEREAS, after a careful review of the said MOA, this Body deems it beneficial and advantageous for the Province to grant the Governor the necessary authority to sign the Memorandum of Agreement on behalf of the PGI;

WHEREFORE, premises considered, upon motion of the Honorable Emmanuel Joselito B. Añes, duly approved and seconded in a session duly assembled, it was –

RESOLVED, AS IT HEREBY RESOLVES, TO PASS A RESOLUTION AUTHORIZING THE GOVERNOR, HONORABLE RODOLFO T.
