WHEREAS, this project will provide resources to train health educators, provide access to critical health information, offer screenings, and facilitate health promotion activities aimed at improving the overall well-being of the people in both urban and rural communities within the Province;

WHEREAS, the Isabela State University - Ilagan Campus, as a higher education institution committed to community extension services, proposes to extend its technical expertise and resources, through its Community Extension and Training Services Office, to contribute to the health promotion activities in partnership with the Gov. Faustino N. Dy Sr. Memorial Hospital (GFNDSMH), the Integrated Provincial Health Office (IPHO), and the Local Government Unit of City of Ilagan, Isabela acting on behalf of the City Health Office-I (CHO-I);

WHEREAS, recognizing the vital role of health education in disease prevention and community well-being, the involved institutions have committed to expanding public awareness campaigns, outreach programs, and healthcare accessibility in Isabela;

WHEREAS, to ensure the efficient implementation of the project, the parties have agreed to formalize their collaboration through a Tripartite Memorandum of Agreement, strengthening health education, outreach, and healthcare services;

WHEREAS, under Section 465, (b) (1) (vi) R.A. No. 7160, the Governor is empowered to represent the Province in all its transactions and sign on it behalf all contracts and such other documents upon the issuance of an authority by the Sangguniang Panlalawigan;
