WHEREAS, Ordinance No. 2024-374, an Ordinance authorizing the Annual Budget of Angadanan, Isabela for Fiscal Year 2025 in the total amount of TWO HUNDRED SIXTY FIVE MILLION FIVE HUNDRED SIXTY TWO THOUSAND SIX HUNDRED FIFTY FOUR PESOS (P265,562,654.00) covering the various expenditures for the operation of the Municipal Government of Angadanan, Isabela and appropriating the necessary funds for the purpose, pursuant to the provisions of Section 327 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991.

A RESOLUTION DECLARING APPROPRIATION ORDINANCE NO. 2024-374 (2025 ANNUAL BUDGET) IN THE TOTAL AMOUNT OF TWO HUNDRED SIXTY FIVE MILLION FIVE HUNDRED SIXTY TWO THOUSAND SIX HUNDRED FIFTY FOUR PESOS (P265,562,654.00) OF THE MUNICIPALITY OF ANGADANAN, ISABELA OPERATIVE IN ITS ENTIRETY SUBJECT TO SOME CONDITIONS

NOW THEREFORE, on motion of SP Member DELFINITO EMMANUEL L. ALBANO duly seconded:

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 2024-374 (2025 Annual Budget) of the Municipality of Angadanan, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of R.A No. 7160 and subject further to the following conditions:

- 1. The lump sum appropriation for the implementation of SSL VI Compensation Adjustment 1st Tranche in the amount of One Million Four Hundred Seventeen Thousand Fifty One Pesos & 86/100 (P1,417,051.86) must be in accordance with Executive Order No. 64 By the President of the Philippines dated August 2, 2024, on the Updating the Salary Schedule for Civilian Government Personnel and Authorizing the Grant of an Additional Allowance, and for Other Purposes, as supported by the guidelines of DBM Local Budget Circular No. 160, dated August 12, 2024, on the Implementation of the First Tranche of the Modified Salary Schedule for Local Government Personnel Pursuant to Executive Order (EO) No. 64, s. 2024;
- 2. The creation of the position under Section 4.5 of the General Provisions of Ordinance No. 2024-374 of Administrative Aide IV with a parenthetical position of Driver II, SG-4 with Item No. 8.7 under the Engineering Office shall not be allowed pursuant to the Qualification Standard (Revised 1997) of the Civil Service Commission and the Manual on Position Classification and Compensation Scheme in LGUs. Item 9.2.1.6 under Chapter 9 of the Manual on Position Classification and Compensation Scheme in LGUs states that the classification of Driver position is dependent on the level/rank of the position they serve. Per established standards, the allowable level of this position for the Municipal Engineering Office is Driver I, SG-3;
- The following Plantilla positions shall be converted to generic class titles in accordance with DBM Local Budget Circular No. 137 dated July 13, 2021, on the Index of Occupational Services, position Titles and Salary Grades in the Local Government (IOS-LGU), CY 2021 Edition, to wit:

4. The position title Local Legislative Staff Employee I under the Office of the Sangguniang Bayan is not equivalent to a parenthetical title Utility Worker, Messenger as per Local Budget Circular No. 137 dated July 13, 2021, on the Index of Occupational Services, position Titles and Salary Grades in the Local Government (IOS-LGU), CY 2021 Edition; Res. No. 2025-03-13 Page 3 of 4

- The positions under the Angadanan Integrated Community Hospital (AICH) shall be in accordance with DBM-DOH Joint Circular No. 2013-1 dated September 23, 2013, on the Revised Standards on Organizational Structure and Staffing Pattern of Government Hospitals, CY 2013 Edition;
- 6. The appropriation for Hazard Pay under the Municipal Social Welfare & Development Office in the amount of Forty Eight Thousand Six Hundred Forty Four Pesos & 45/100 (P48,644.45) shall be in accordance with DSWD Memorandum Circular No. 05, S. 2022 and the DBM-DSWD Joint Circular No. 1, s. 2018 dated December 1, 2018 on the Rules and Regulations on the Grant of Compensation-Related Magna Carta Benefits to Public Social Workers (PSWs) as supported by AO No. 05, S. 2023 and AO No. 06, S. 2023;
- 7. The Subsidy to Solo Parents in the amount of Three Million Five Hundred Forty Thousand Pesos (P3,540,000.00) shall be in accordance with Section 17 (b) (2) (iv) of RA No. 7160, and Section 12 of RA No. 11861 on the Expanded Solo Parents Welfare Act as supported by Local Budget Memorandum No. 87 dated June 9, 2023, and shall be implemented with the guidelines to be issued by the DILG;
- 8. The appropriation for Legal Services, Other Professional Services, Environmental Services and Other General Services in the amount of Fifty Five Thousand Pesos (P55,000.00), Six Million Five Hundred Thirty Eight Thousand Pesos (P6,538,000.00), One Million One Hundred Thirty Nine Thousand Five Hundred Pesos (P1,139,500.00) and Sixteen Million Eight Hundred Seventeen Thousand Seven Hundred Pesos (P16,817,700.00) respectively, shall be in accordance with COA Circular No. 2015-009 dated December 1, 2015, on the Description of Accounts under the Revised Chart of Accounts for Local Government Units;
- 9. The utilization of 5% LDRRMF shall be in accordance with the approved Local Disaster Risk Reduction and Management Plan pursuant to RA 10121 and its implementing Rules and Regulations, as supplemented by NDRRMC-DBM-DILG JMC No. 2013-1 dated March 25, 2013. Provided further, that the LDRRMF Plan shall be reviewed by the Office of Civil Defense (OCD) pursuant to RA 10121 and its implementing Rules and Regulations as supplemented by Local Budget Memorandum No. 90 dated June 13, 2024, copy furnish the Office of the Sangguniang Panlalawigan of the reviewed LDRRMF;
- 10. The appropriation for the 20% Development Fund shall strictly cover only the development projects prescribed and authorized under DBM-DOF-DILG Joint Memorandum Circular No. 1 dated November 4, 2020 as supplemented by DBM-DOF-DILG Joint Memorandum Circular No. 1 dated April 27, 2023;

11. All procurement activities shall be governed by the provisions of Republic Act No. 9184, the Government Procurement Reform Act (GPRA) and its Implementing Rules and Regulations. Further, the acquisition of Transportation Equipment (Elf Type Boom Truck) in the amount of Three Million Pesos (P3,000,000.00) shall be subject to the provisions of Budget Circular No. 2022-1 dated February 11, 2022 on the Omnibus Guidelines on the Acquisition, Use, Rental, and Replacement of Government Motor Vehicles;

RESOLVED FURTHER, to require the Municipality of Angadanan, Isabela to comply with the herein review findings and/or conditions and notify this body of actions taken thereon.

RESOLVED FURTHERMORE, to furnish the Municipality of Angadanan, Isabela that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations.

RESOLVED FINALLY, to furnish a copy of this Resolution to the **Honorable JOELLE MATHEA S. PANGANIBAN**, Municipal Mayor, and to the Sangguniang Bayan of the Municipality of Angadanan, Isabela through the **Honorable DIOSDADO S. SIQUIAN**, Municipal Vice-Mayor.
